LIMITED WARRANTY GUARANTEE

WHAT IS COVERED?

If you have purchased a Paramount Mattress and use it with a proper Foundation (notation 1) this warranty covers manufacturing defects in your Paramount Mattress or Foundation. Replacement of one piece does not automatically result in the replacement of the other piece. For this limited warranty to be valid, 1) you must be the original purchaser and have purchased the sleep set from one of our authorized dealers in the U.S., 2) you must provide a copy of the original store receipt or other proof of date, place of purchase and purchase price and 3) the law label must be attached to the product. Replacement or repair of your defective mattress and/or foundation is the only remedy under this warranty. If identical materials are not available at the time of product service, Paramount Bedding reserves the right to substitute materials of equal or higher quality or (at Paramount Beddings discretion) provide a refund. You are responsible to rotate (one sided bed) or flip and rotate (two sided bed) your mattress monthly.

LENGTH OF WARRANTY:

The warranty coverage starts on the date of purchase. Repair or replacement is at the discretion of Paramount Bedding and repair or replacement of the mattress or foundation does not extend its limited warranty or begin a new limited warranty period. To determine how long your warranty will last, please refer to the product's law tag and warranty code (see warranty period chart).

WHAT THIS WARRANTY DOES NOT COVER

- Normal body impressions of 2" or less
- Mattress or Foundation exposed to Cigarette or Tobacco Smoke
- Firmness/Comfort preference of the product
- Excessive Weight
- Bed height
- Cover (fabric) we recommend you use a mattress pad
- Bent border/Grid wires which run along the mattress and foundation perimeter and can be bent during installation, moving or bending of the sleep set
- Burns, stains or soil
- Mattresses not used with a proper foundation (notation 1)
- Merchandise sold As-is/"Distressed"/"Floor Model"/"Clearance"
- Adjustable foundations
- Claims made outside the 50 United States
- Transportation, inspection or removal costs of product
- Replacement of another, non-defective piece in the sleep set
- Paramount product that has a manufacturing defect and is stained or soiled. Due to health and safety reasons, Paramount may not be able to inspect these products to assess whether this is covered by the warranty, in which case, Paramount reserves the right to deny warranty coverage.
